1. This event is exclusively for Jim Cronin Memorial Fund Charity members or Monkey World Adoptive parents and their guests only. This event is not open to members of the general public and membership numbers will be checked at the point of booking.
2. Bookings for this event (Great Big Weekender) can only be taken over the telephone and are subject to the Booking terms and Conditions below.
3. Full payment is required at the time of booking. Confirmation of your booking will be sent to you by post within 10 working days, unless payment is made by cheque in which case confirmation of booking will not be issued until the payment has cleared.
4. Event lanyards and passes for participants of packages, A, B, C, & D will be issued on arrival.
5. Bookings for this event and Passes are valid for named attendee only and cannot be transferred.
